1. That I was formerly known and addressed as Garba Sarkin Kabi usually shortened as "**Garba S/Kabi**" and Garba Adamu Kebbe.
2. That words "**Sarkin Kabi**" is the Traditional Stool Title of the District Head of Kebbe which my Father Sarkin Kabi "**Adamu**" of Blessed Memory occupied before his death while "**Kebbe**" is my Home Town and is sometimes added to distinguished my name from similar names by tying it to my Home Town.
3. That I used the title of "**S/Kabi**" as my surname and "**Garba**" as my first name till recently and now wish to bear my father's name "**ADAMU**" since he is no more the District Head and also want to use Abubakar my real name as my first name instead of **Garba** which is one of the nicknames of **Abubakar** so as to personalise my identity.
