1.0 INTRODUCTION

4.0 ELIGIBILITY REQUIREMENTS

- (i) Evidence of Business Name or Certificate of Incorporation with Corporate Affairs Commission (CAC) attach with Form CAC 2 & 7 (or CAC1.1).
- (ii) Evidence of Company's Current tax Clearance Certificate for the last three years (2017, 2018 and 2019) and or Income Tax Clearance Certificate valid till 31st December, 2020.
- (iii) Evidence of Registration on the National Database of Contractors, Consultants and Service providers by inclusion of Interim Registration Report (IRR) issued by the Bureau of Public Procurement (BPP) Expiring by 31st December, 2020 or valid certificate issued by BPP.
- (iv) Current Compliance Certificate with Nigeria Social Insurance Trust Fund (NSITF), expiring 31st December 2020.
- (v) Current Pension Compliance Certificate in Compliance with amended PENCOM Reform Act, 2014, expiring 31st December 2020.
- (vi) Current ITF Compliance Certificate issued by ITF in Compliance with Section 6(2) of ITF Amendment Act 2011, expiring 31st December 2020.
- (vii) Audited Accounts for the past three financial years (2017, 2018 and 2019).
- (viii) List of verifiable/relevant documentary evidence of similar jobs successfully Executed/ongoing within the last five (5) years (e.g. letter of Award, Job Completion Certificates etc.);
- (ix) Current Practicing License as an Auctioneer;
- (xi) All documents for submission must be transmitted with a covering/forwarding letter under the company/Firm's letter head paper bearing amongst others, the registration number (RC) as issued by the Corporate Affairs Commission (CAC), contact address, Telephone Number,(preferably GSM No.), and e-mail address. The Letterhead paper must bear the names and Nationalities of the Directors of the Company at the bottom of the page, duly signed by the authorized officer of the firm.
- (xiv) Current sworn affidavit disclosing:
 - That the company is not in receivership, insolvent or bankrupt;
 - That the Company does not have any Director who has ever been convicted in any court in Nigeria or any other Country for criminal offence in relation to fraud or Financial impropriety;
 - Whether or not any officer of INEC is a former or present Director, Shareholder or has any pecuniary interest in the bidder.
 - That all documents submitted for the bidding are true and correct in all particulars.
