# **INEC READY FOR ANAMBRA POLL**

hen the Independent National Electoral Commission (INEC) affirmed its readiness to conduct the November 6, 2021 Anambra Governorship election in the face of glaring security challenges in Anambra and surrounding states, the Commission was not mincing words.

Speaking at an emergency meeting with members of the Inter-Agency Consultative Committee on Electoral Security (ICCES) held October 5,

2021, where he also declared INECs readiness to go ahead with its Timetable and Schedule of Activities for the election, the INEC Chairman, Professor Mahmood Yakubu, Chairman recalled that the Commission's State Office in Awka was attacked in May, resulting in the destruction of all nonsensitive materials assembled for the governorship election. Besides, the store, collation centre and main office

building were either totally or substantially damaged, in addition to the loss of several vehicles used for electoral activities.

He said: "Happily, we have almost fully recovered from that attack. The destroyed buildings have either been completely repaired or are nearing completion, and we have fully

replaced the materials destroyed. This rapid recovery has only been possible because this is an off-season election. We have sourced some of these materials, such as the 326 electric generators and vehicles destroyed in the attack from the neighbouring states. However, should we again lose vital materials and facilities, the ongoing preparations will be adversely affected."

Afterwards, the Commission embarked on printing the manual copies of the Register containing 2,525,471 voters to be used during the election. The Anambra REC also informed Leaders of Political Parties during the presentation ceremony that the Commission would print the Permanent Voters' Cards (PVCs) for collection by the new registrants ahead of the 6th November polls.

Other ongoing activities preparatory to the November 6 governorship election in Anambra state include; series of Trainings and Capacity Building for staff to be deployed for the election, Stakeholders' engagements at State and Local Government Levels, as well as Voter Education and public enlightenment.

The Commission also activated the online portal for accreditation of

reputable Media organisations intending to deploy staff to cover the election on Monday, 4th October, 2021 for a period of 3 weeks, till 26th October 2021.

Already, the Commission has accredited some 83 Civil Society Organisations to serve as Observers for the election. Out of that number, 77
